The contractor will provide electrical and instrumentation services in Block 3/05 and other associated support services in support of client maintenance and projects that will aim to significantly increase the availability of critical equipment, personnel and facilities safety.

SCOPE OF WORK

Electrical and instrumentation services in Block 3/05 and other associated support services for maintenance and projects will consist of the following (but not limited to):

- Have a sufficiently competent and trained team and, upon the imposed request;
- Needs assessment and elaboration of work scopes, technical and commercial proposals;
- Preparation of technical procedures to be used during interventions;
- Preparation of the work plan and all technical documentation necessary for the efficient execution of the work;
- Inventory of spare parts of the Company and provide the appropriate recommendations;
- Preparation of the list of special tools to be used during interventions;
- Conducting offshore visits so that together with the Company can better define the project implementation plan;
- Preparation of integrated schedule with critical path mention
- Preparation of lifting procedures (lifting)
- Verification of certificates and calibration of instruments and tools to be used during the mission;
- Technical support and labour services;
- Installation, commissioning and start-up services;
- Issuance of daily reports during the offshore stay indicating the constraints and actions taken;

PROGRAMMING

GENERAL REQUIREMENTS

The tasks and activities to be performed by the CONTRACTOR during the execution and completion of the services. However, unless expressly stated otherwise in any work order, as a rule, specific services for replacement, installation and / or commissioning of electrical and

instrumentation equipment and / or systems shall be performed in accordance with the generalspecifications and standards of the Agreement, which is in more detail in the applicable standard.

OTHER REQUIREMENTS

The Contractor shall submit all proofs / certificates attesting to its suitability for performing similar work, qualifications and certifications to the appropriate effect, as well as advanced knowledge of the use of the SAP PM / MM module tool.
